

# Red Traffic Axes

The circulation of public transport vehicles is prohibited on the following roads :

- Promenade des Anglais, between Avenue des Grenouillères and Quai des Etats-Unis,
- Avenue Max Gallo,
- Boulevard Jean Jaurès,

- Boulevard Risso, between Avenue Saint Sébastien and Rue Caissotti,
- Avenue Galliéni,
- Avenue Saint Jean-Baptiste,
- Avenue Félix Faure,
- Avenue de Verdun,
- Rue Barbéris, between Rue de Roquebillière and Boulevard Risso,
- Rue Delille, between Rue Gioffredo and Avenue Saint Jean-Baptiste,
- Rue Defly, between Rue Gioffredo and Avenue Saint Jean-Baptiste,
- Rue Chauvain, between Rue Gioffredo and Avenue Félix Faure,
- Quai Papacino,
- Quai de la Douane,
- Quai Lunel,
- Quai Rauba Capeu,
- Quai des Etats-Unis,
- Rue de Foresta, between Rue Robilant and Quai Rauba Capeu,
- Rue du Congrès, between Rue de la Buffa and Promenade des Anglais,

Exemptions are provided under Municipal Order No. 2025-04805 dated October 27, 2025, which repeals Municipal Order No. 2025-03429 dated August 12, 2025, governing the circulation of public passenger transport vehicles along the Promenade des Anglais and adjacent roads bordering the Promenade du Paillon.

Authorization for circulation is granted to:

- Tourist coach operators that have entered into contractual agreements with hotels for the transportation of guests to or from said establishments, subject to the presentation of supporting documentation evidencing such agreements;
- Tourist coach operators transporting clients to restaurants, beaches in Nice, and museums located along the designated "red routes," upon presentation of a valid transport voucher specifying the destination establishments.
